**1** Briefly describe the organization's mission or most significant activities  
AIRCRAFT CARRIER HORNET FOUNDATION DBA USS HORNET SEA, AIR, AND SPACE MUSEUM (THE FOUNDATION), IS A NOT-FOR-PROFIT CORPORATION INCORPORATED IN 1995. THE FOUNDATION MAINTAINS THE USS HORNET, A DECOMMISSIONED UNITED STATES NAVY AIRCRAFT CARRIER WITH HISTORICAL SIGNIFICANCE, AS AN AIR, SEA, AND SPACE MUSEUM AND TO FURTHER EDUCATION ABOUT WORLD WAR II, THE KOREAN AND VIETNAM WARS, SPACE EXPLORATION AND NAVAL LIFE AMONG ITS PATRONS. THE UNITED STATES NAVY APPROVED THE USE OF THE SHIP AS A MUSEUM ON CONTRACT VIA THE HISTORIC SHIP DONATION PROGRAM IN 1998. DURING A NATIONAL EMERGENCY, AT THE GOVERNMENT'S REQUEST, TITLE TO THE VESSEL MAY REVERT TO THE GOVERNMENT. ACCORDINGLY, THE VALUE OF THE SHIP WAS NOT RECOGNIZED ON THE FOUNDATION'S FINANCIAL STATEMENTS. THE FOUNDATION HAS RESTORED A SIGNIFICANT PORTION OF THE SHIP AND COMMENCED THE OPERATION OF THE MUSEUM. THE USS HORNET AND ITS RELATED MUSEUM ARE LOCATED AT ITS PRESENT SITE AT ALAMEDA POINT, CALIFORNIA.
