I got all the dough in the safe, a total of \$380.00. I get paid on the 1st of July. Won't be in port at all. Might get in there at Iwakuni around July. I'm going to start on your letter of the 28th of May. Yep, I'll forget the Nikon S-2. I'll get the Linhof before I get home. But I won't be shooting any pictures. Not too many anyway. I'm glad that Tiny finally tounded a rabbit as I sort of thought that he wouldn't even bark at one. Ha Ha. I received some transparencies and sent them back home already. I'm going to take the accessories to the post office tomorrow and mail them then come back and wrap the fishing rod that I paid 480Yen. Yep, I sure did shoot a lot of film. If you were where I had been I bet that you would have shot a 1000 pictures. I hope that you have a good day out fishing next time. Nope the lenses

weren't any better than the ones you have on the Leica. I like the LEICA and no one will change my mind on it. Sure is one swell camera. It's been raining all day long and nothing doing for most of the day. Not too many flights. Guess ~~what~~? I bilut the wing of the "WILDCAT" last night and will work on it tomorrow night. Tonight I am going to hit the sack early and take it easy Ha Ha. You'll have to try something else or the Hell Razor will be a flop. Maybe ~~Willie~~ built it wrong also. Ha Ha. It works perfectly with the Speed and I can put the film on a training job order and shoot lots of film.. I was always kidding about the 800MM lens. I'm not that full of \$\$\$\$\$\$. Ha Ha. I hope that you and Mom liked the picture "CINEORAMA" as I heard that it was very good. I'm sure you did

Returned to Yokosuka feeling low and then ran into shop by accident and sold for \$170.00 so I don't think I done too bad as they only wanted to give \$145.00 the hell with them so I know they will ~~waken~~ make \$\$\$ on it anyway so IX sold it then. Well I guess I didn't do 4.0 on the Contax or Rollie. Just about 3.5 I guess. But I think the Rollie had seen the course and the Contax also. I think I ~~do~~ got some sand in the shutter at Waikiki on the Contax. Ha Ha. It's sold now and so much the better. I didn't get one bad bill either.
